

Annual Winter Fisheries Meeting held December 17th

The Aleutians East Borough Natural Resources Department (NRD) hosted the annual Winter Fisheries meeting December 17th, 2024 virtually via Teams at AEB meeting sites, simulcast on KSDP radio. The meeting audio is archived here https://apradio.org/mp3/2024-12-17-aebfish.mp3. Alex Perry with NOAA Office of Law Enforcement assembled agency experts and moderated the event. Following are the meeting notes as compiled by AEB NRD.

<u>Nat Nichols</u> is ADF&G area manager for shellfish and groundfish. <u>Cassie Whiteside</u> is the Assistant manager – they can be contacted at (907) 486-1840. Fishermen are reminded of the importance of catch reporting and to facilitate the work of ADFG samplers to collect data.

South Peninsula Tanner Crab

The 2025 South Peninsula District commercial Tanner crab guideline harvest level (GHL) will be 210,000 pounds in the Eastern Section. The Western Section will remain closed for the 2025 commercial Tanner crab season. The Tanner crab season will open at 12:00 noon on January 15, 2025 unless delayed by weather. The crab pot limit will be 20 pots per vessel. Vessels greater than 58 feet in overall length may not participate in the South Peninsula District commercial Tanner crab fishery. ADF&G has established subsection harvest targets for the 2025 commercial Tanner crab fishery in the Eastern Section of the South Peninsula District. The Eastern Section will be divided into two subsections (Pavlof and Shumagin) using the 161°W long line; both subsections will be managed using a 105,000-pound harvest target. Vessel operators must register to fish in either the Pavlof or Shumagin Subsection. Bouy tags will be available in the King Cove Harbor and the Sand Point Trident office. State Waters Pacific Cod

The South Alaska Peninsula Area state-waters Pacific cod pot gear season will open at 12:00 noon March 7, 2025 or seven days after closure of the Western Gulf of Alaska (WGOA) federal/parallel Pacific cod pot gear sector A season, whichever is later. The South Pen Pcod GHL is similar to last year at 4,896,527 lbs for pot gear and 864,093 lbs for jig gear. GHL and opening notice:

The Dutch Harbor Subdistrict Pacific Cod GHL for pot gear is set for 44,026,000 lbs, and will open 7 days after the federal BSAI under 60ft hook/line and pot gear season closure. The jig gear GHL is 100,000 lbs and the jig gear season will open May 1st. Tags and registration for the Dutch Harbor Subdistrict cod fishery can be obtained through the Dutch Harbor office. Notice:

Federal fisheries

Bering Sea/Aleutian Islands proposed 2025 groundfish harvest specifications, as presented in the <u>Federal Register</u>. <u>Inseason Adjustment</u>.

Gulf of Alaska proposed 2025 groundfish harvest specifications, as presented in the Federal Register. Inseason Adjustment for pollock and Pacific cod.

- 'A' Season allowance for pollock in Area 610 5589mt
- 'A' Season allowance for Pacific cod WGOA trawl CV 1856mt
- 'A' Season allowance for Pacific cod WGOA pot gear 1165mt

The Central Gulf of Alaska Rockfish fishery opens April 1st this year changed from May 1st. Pacific cod TACs similar to last year's.

Thanks in part to the Western Gulf trawl fleet and AEB's Fishery Analyst Charlotte Levy, Electronic Monitoring for trawl is implemented as a regulatory program in 2025, with near 100% participation, similar to the exempted fishery permit (EFP) program. A FAQ will be available soon. Components:

- Vessel Monitoring Plan must be aboard vessel at all times paper or electronic copy.
- Logbooks required, eLogbook or paper copy.
- Vessels must communicate with processing plants.
- Program encourages best practice of retention of all catch some discards allowed
- Every salmon is counted no more extrapolation provides more precise salmon accounting

Charlotte noted there will be an early January pre-season meeting to go over all changes to EM program.
